

# ARRIVING IN AUSTRALIA?

Welcome to the land of Sun, Surf, Detention  
Centres and Institutionalised Child Abuse.

You may THINK that this does not concern YOU.

But all non-citizens without a visa in Australia face indefinite mandatory detention, without charge or trial. In fact all that is required to justify detention is a suspicion of someone not having a visa.

All persons with a visa may have that visa summarily cancelled without notice and are then subject to mandatory detention.

That is Australian Law.

In Sydney a man had his visa cancelled without notice on arrival, was detained at Villawood Detention Centre, and hanged himself within 24 hours.

In Perth Immigration Detention Centre there is one Asylum Seeker who has been in detention since September 1998. This is in spite of the fact that the Australian system of refugee determination accepted his accounts of torture and imprisonment in his conflict ravaged homeland. They continue to hold him even though he has cooperated with efforts to deport him and they still have been unable to secure his deportation.

Children, even unaccompanied children, are held indefinitely. This is in direct violation of the 1983 Convention on the Rights of the Child. A case of a seventeen year old in Baxter Detention Centre in South Australia was recently discovered. He has been in detention for three years, and upon initial arrival had been "screened out". This means that he was not even allowed to apply for protection, simply locked up indefinitely without charge or trial.
